

Debt securities shall be limited to federal agency, federally insured obligations or investment grade corporate bonds. There shall be no investment transactions involving stock options, short sales, purchases on margin, letter stocks, commodities or venture capital. The Foundation shall not make any investments that are inconsistent with the terms of its charter or which would jeopardize its tax-exempt status.
Part X, Line 2	The Foundation is exempt from Federal income taxes under Section 501(c)(3) of the Internal Revenue Code and is recognized as such by the Internal Revenue Service. The Foundation has also been classified as an entity that is not a private foundation within the meaning of Section 509(a)(3). The provisions included in accounting principles generally accepted in the United States of America provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribe a threshold of "more likely than not" for recognition of tax positions taken or expected to be taken in a tax return. The Foundation performed an evaluation of uncertain tax positions as of April 30, 2014, and determined that there were no matters that would require recognition in the financial statements or which may have any effect on its tax-exempt status. As of April 30, 2014, the statute of limitations for fiscal years 2011 through 2014 remains open with the U.S. Federal jurisdiction or the various states and local jurisdictions in which the Foundation files tax returns.
