Programs such as Healthy Start, Healthy Children in Transition, The Healthy Kids Fun Fair, Healthy Children with Special Needs, Health STARS and Done in a Day cumulatively hosted over 30 events providing over 500 volunteer opportunities to our League members. Our community programs partnered with 20 nonprofit organizations and 7 area schools and reached over 4500 children and their families during this year. Community Assistance Funds and Community Enrichment Grants distributed \$124,000 to 13 community
