The St John Auxiliary, Inc has services at the Medical Center in Tulsa, Owasso, Broken Arrow, and support services in Sapulpa Youth education is an important focus for us We continue to expand and enhance services for teens through Generation Impact We hosted 318 students from 37 area high schools and a few that are home-schooled, and taught them about opportunities in the medical field by allowing them to volunteer and shadow in approximately 100 different areas throughout the health system We have lecturers come in and speak about their areas of expertise, and host seminars for students In this past year we also had an internship program at Broken Arrow with the Broken Arrow high school where students could earn high school credits toward graduation and learn about the hospital There were 16 students who participated and each student had two placements, one for fall semester and one for spring semester In this past fiscal year, we had 180 active adult volunteers Between the adults and the juniors, over 100,000 hours were contributed to the St John Health System through various areas including the information/guest services desks, surgical waiting, pastoral care, gift shops, family care, ICU waiting areas, cuddling for NICU babies, Emergency Rooms, dismissals, flower deliveries, and medical/surgical areas The St John Auxiliary Inc, has also been an important source of financial assistance for St John, donating funds each year for important medical care and visitor services improvements The Auxiliary is currently working on a \$2.5 million pledge to fund the "Next Generation Da Vinci Surgical Robot" Contributions for Fiscal Year 2014 totaled \$525,000 in financial donations and \$4,200 in "In-Kind" donations for a total of \$529,200 Other services include crocheted baby caps and blankets, quilted baby blankets, providing memory boxes to pastoral care, care of the porcelain figurines in the main lobby of the medical center, decorating the Christmas tree in the main lobbies, collecting and distributing magazines to waiting areas and patients, and making bags of crayons and coloring pages for kids in waiting areas
