Other expenses in 2013 included $\$289.11$ in conference calls for board members and editors to meet during the year; it also included video processing fees for the "Our Mentors Speak" series, which was recorded at the annual conference ($\$109.27$), the remainder of other expenses consisted of refunds for conference registration for registrants who did not come to the conference ($=\$501.20$). Total other expenses = $\$10,151.48$
