WVBBS/SEF Scholarship Funds – Short Descriptions

The Anna MacIntyre Scholarship Fund (AMC) was created by Anna MacIntyre, a Emeritus Trustee and former Board Chairperson, from earnings received for BBTS' volunteer support of World Cup races in the 1970s as well as memorial donations over the years. Awards in the amount of \$250 are given out annually to defer the cost of membership. This is a first come, first serve award with an annual maximum of \$2,500, or ten scholarships.

The Phillip and Elizabeth Gross Family Foundation (PEGFF) is a private, Boston based foundation, that wishes to remain ANONYMOUS. We came into contact with the foundation when an athlete they chose to sponsor, chose WVBBS/SEF as the place they wanted to train. In 2011-2012 we submitted a scholarship grant request based on specific amounts for specific student-athletes. This same pattern will be followed in 2012-2013. These funds are given out on the basis of clear and demonstrable financial need to students who, without the foundation's help, would be unable to participate due to cost. Unused funds are accounted for in one of two ways. If the student-athlete is returning for the next season, funds are deferred for that individual. If the athlete is not returning to WVBBS/SEF, the funds revert to a general pool to be re-distributed based on the same initial financial need set forth by the donor.

The Pat Moore Scholarship Fund (PMSF) was codified into its present form during the 2011-2012 fiscal year. The primary source of funding is Pat Moore, a world famous snowboarder who was helped with financial aid to participate in WVBBS/SEF programming. The fund also accepts cash and product donations from individuals and organizations. One full scholarship is given to a promising young snowboarder who lives within SAU 48. Other applicants may receive assistance in the form of tuition/fee remission, travel miles, equipment or clothing. WVBBS/SEF's Scholarship Committee, in conjunction with the head snowboard coaches selects a preliminary slate, with final decisions made by Pat himself. Generally, this scholarship benefits between 4-6 athletes annually.

The Dylan Peters Art of Snowboarding Memorial Scholarship (DPAoSMS) Dylan Peters was a talented WVBBS/SEF snowboarder who tragically lost his life in an auto accident. His parents set up this scholarship, that is funded through their Vanguard Charitable Endowment Program. At the end of the season, one talented snowboarder, who embodies passion, team spirit and camaraderie, is selected by the head coaches to receive \$500 to offset their WVBBS/SEF training fees. Should the recipient be a graduating high school senior, the money may support their first semester tuition to the college they have been accepted at and committed to attend.
