**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
JOHN STACY LYONS MEMORIAL FOUNDATION, INC.**

Tom Lemmon and Brigette Browning certify that:

1. They are the President and Secretary, respectively, of John Stacy Lyons Memorial Foundation, Inc., a California nonprofit public benefit corporation.
2. The articles of incorporation of this corporation are amended and restated to read as follows:

**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
JOHN STACY LYONS MEMORIAL FOUNDATION, INC.**

ARTICLE ONE

The name of this corporation is John Stacy Lyons Memorial Foundation, Inc.

ARTICLE TWO

A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

B. This Corporation will honor the name and spirit of John Stacy Lyons by providing financial support to charitable entities that improve the welfare of the Greater San Diego community (of which Mr. Lyons was a long-time resident). The Corporation will support charitable organizations that conduct research leading toward the cure for cancer, leukemia, lymphoma, and other diseases (Mr. Lyons having died of bone marrow cancer/leukemia.). The Corporation will also support community-based activities that encourage children, promote the middle class, and honor the working men and women in the Greater San Diego community.

ARTICLE FOUR

A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation

exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

ARTICLE FIVE

A. The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.


Personal liability of all directors of the corporation to the corporation for monetary damages of breach of duty of care or other duties as a director is hereby eliminated to the extent allowed by the California Nonprofit Corporation Law. To the fullest extent provided by California law, the private property of the directors shall be non-assessable and shall not be subject to the payment of any corporate debts, nor shall the directors of the corporation become individually or corporately liable or responsible for any debts or liabilities of the corporation.

3. The foregoing amendment and restatement of the articles of incorporation has been duly approved by the board of directors of this corporation.


