The SwedishAmerican Foundation is the fund development and charitable gifts arm of the SwedishAmerican Health System The Foundation solicits and collects gifts from individuals, organizations, and corporations primarily within the greater Rockford community and surrounding counties, and uses that money to create and support programs and programming which help make the greater Rockford area a healthier place within which to live, work, worship and raise families, and to assist SwedishAmerican Hospital and its subsidiaries in the provision of superior care for its patients

SwedishAmerican Foundation (SAF) supports SwedishAmerican Hospital, a 501(c)(3) organization in its mission to provide quality medical healthcare to communities in Northern Illinois and Southern Wisconsin regardless of race, creed, sex, national origin, handicap, age or ability to pay During the current year, SwedishAmerican Foundation provided additional funding grants to SwedishAmerican Hospital for a meditation garden and a shuttle service for the new SwedishAmerican Regional Cancer Center which opened in October of 2013 In addition, smaller grants were provided to specialized departments within the SA Hospital, which helped enhance patient care and patient-visitor comfort

In 2005, SAF, as part of its mission to revitalize the neighborhood surrounding the hospital campus, purchased and renovated group of run down rental housing units directly across the street from the hospital campus, for the purpose of providing safe, secure, and affordable near-campus housing for on-call hospital staff and medical students from the University of Illinois Rockford campus who are interning at SA Hospital Program expenses relating to this mission project include the services of a salaned property manager in addition to all of the rental unit expenditures relating to repairs, maintenance and utilities which are also provided by SAF

Beginning in 2004, SwedishAmerican Foundation's (SAF) Board approved \$360,000 to be designated as funding for the neighborhood revitalization program SAF has purchased a total of 30 older homes in the 6 block area surrounding SwedishAmerican Hospital for the purpose of making them saleable to employees, firefighters, police officers, and public school teachers at a price less than cost of purchase and renovation To date, 26 of the homes were sold to owner-occupants Funds utilized for homes purchased/renovations are recycled back into the program upon sale of the renovated home During the fiscal year, the Foundation incurred over \$56,000 in operational expense for utilities, property taxes, lawn-care, snow removal, and minor repairs and maintenance on the properties that were in various stages of renovation This program will continue for at least three additional years In cooperation with Rockford East High School and De la Gardie High School/Gymnasiet (Lidkoping, Sweden), the SwedishAmerican Foundation constructed two new neighborhood houses available for sale to employees or other eligible owner-occupants

One of the most complex healthcare issues to many Medicare recipients is related to Medicare billing issues SwedishAmerican Health System has employed a full-time Medicare counselor fee-free to the public for the last 29 years This service, now offered through SAF, is available at both the Rockford and Belvidere campuses While many other hospitals have discontinued this public service, SAF continues the SwedishAmerican tradition of offering this priceless service to Medicare recipients regardless of their ability to pay for such services Although many of those accessing this free benefit live within our community, this unique service is not limited to patients of SA Hospital It has also drawn Medicare recipients whose healthcare services were performed at hospitals and clinics outside of the SwedishAmerican service area As an outreach of SA Hospital, SAF recognizes the needs of our retired and current employees and their families in addition to those who reside within the Rockford, Belvidere and surrounding areas Some of the many community outreach services provided by SA Foundation during this fiscal year include 1) providing will-writing and retirement planning services to employees to help prepare for their future needs, 2) sponsoring the cost of school physicals and comprehensive heart exams for school-age children in our area, 3) contributions of \$155,000 in community grants and over \$128,000 in sponsorship donations to other not-for-profit organizations, many of which provide other health and quality of life/living services and benefits to our community
