The president's compensation recommendations are discussed and reviewed by the presidential review committee however they are not formally voted upon. This process was last undertaken in October 2013 for the following ICA employee positions: Vice President of Finance, Vice President of Advancement, Vice President of Media and Engagement, Vice President of Student Affairs and Vice President of Education Programs.
