Potential conflicts of interest are addressed by the Board Chair and reviewed by the Audit Committee.
Form 990, Part VI, Section B, Line 15	Compensation for the President is based upon terms of an employment contract. The Board Compensation Committee annually reviews the performance and salary level. The review includes interviews with faculty, staff and students. The salary is compared to colleges in the college's aspirant peer group and other private college presidents as reported in the national and state surveys. The external auditor also reviews the information with the audit committee. Compensation of the Vice Presidents (VP for Business & Finance, VP for Academic Affairs, VP for Institutional Advancement, VP for Student Life/Enrollment, VP for Communications & Marketing) is based on individual performances and comparison of peer group salary levels for comparable positions. The president prepares the annual evaluation with input from the faculty senate, and presents compensation recommendations to the board compensation committee for their approval. The compensation and comparison data is also presented to the college's external auditors for their review. The external auditor reviews the information with the board audit committee. The compensation committee meets annually in August and the audit committee meets annually in October. For this tax year the compensation committee met on August 22, 2013 and the audit committee met on October 11, 2013.
