OUR COMPASSIONATE SERVICES EMPOWER REFUGEES TO ACHIEVE SELF-SUFFICIENCY. RECEPTION AND PLACEMENT SERVICES ASSIST REFUGEES DURING THEIR FIRST 30 DAYS IN THE COUNTRY. SERVICES INCLUDE. AIRPORT PICKUP AND TRANSPORTATION, SAFE AND SANITARY HOUSING, INCLUDING ESSENTIAL FURNISHINGS, FOOD, CLOTHING, ASSISTANCE APPLYING FOR SOCIAL SECURITY CARD, WORK AUTHORIZATION, HEALTH SCREENINGS AND OTHER NECESSARY APPOINTMENTS.

THE COMBINATION OF HOUSING AND COMPREHENSIVE CASE MANAGEMENT HAS PROVEN TO BE A COST-EFFECTIVE WAY TO HELP HOMELESS FAMILIES MAINTAIN PERMANENT HOUSING WHILE LIVING A MORE STABLE, PRODUCTIVE LIFE. THE SCHOOL SOCIAL WORKER IS SEEN AS PART OF A TEAM, WORKING WITH SCHOOL STAFF, PARENTS OR GUARDIANS, AND STUDENTS TO PROMOTE ACADEMIC SUCCESS, EMOTIONAL WELL-BEING, AND POSITIVE PERSONAL RELATIONSHIPS. CURRENTLY, THE PROGRAM SERVES 25 CATHOLIC STUDENTS UNDER THE SUPERVISION OF THE ARCHDIOCESE OF INDIANAPOLIS.
