Second year of operations of a PreK through 6th grade Classical Christian School. Our preschool consisted of 2 year old, 3 year old and 4 year old classrooms. Our grammar school consisted of Kindergarten through 6th grade. We completed our second school year with 52 students enrolled in preschool and 97 students enrolled in grammar school. Our classical curriculum includes study of literature, music + art theory, mathematics, sciences, history and various religious studies. In late August 2014 we commenced our third school year operating a PreK through 7th grade Classical Christian School. Our beginning enrollment for our third school year was 47 students in PreK and 135 students in Kindergarten through 7th grade.
