Anderson University (University) is a comprehensive university affiliated with the South Carolina Baptist Convention offering bachelors, masters, and doctorate degrees. Located on approximately 271 acres in the upstate region of South Carolina near the foothills of the Appalachians, the University features a rigorous education in a supportive Christian environment. The University offers 39 baccalaureate majors with 26 minors. The University also offers seven master degrees in the fields of business, education, criminal justice, and ministry and music education, and one program at the doctoral level, the doctor of ministry. **HIGHLIGHTS OF THE YEAR ENDED 5/31/14** The University continued on a decade-long spiral of growth in the 2013-2014 academic year. Enrollment at the University reached approximately 3,000 in the fall of 2013, marking an increase of more than 82% in the past nine years. The 5th new residence hall constructed in the past seven years to accommodate the growth is nearing completion and will be ready for Fall 2014. Like an identical residence hall that opened in the fall of 2013, the newest facility will house 102 students. The University also expanded its presence at the University Center of Greenville in 2014, adding a bachelor of criminal justice program to the previously existing MBA program. A new bachelor of business administration in healthcare management is underway with plans for more new degrees in the coming academic year. The University improved on its already stellar ranking in the U.S. News & World Report Best Colleges list (#20) and was named one of the "46 Up and Coming" institutions nationally. The University was named one of "America's Best College Buys" for the 7th consecutive year, and in the spring of 2014, was named by U.S. News & World Report as the #2 regional college in the South for efficiency (combining academic quality while holding down cost).
