Instruction For the academic year 2013-14, enrollment remained steady with an average of 3300 undergraduate and graduate students completing traditional, online, and hybrid courses There were 596 degrees conferred during the year, and the total number of full-time professors was 150 CSU's Nursing program continues to boast the best 7-year pass rate in South Carolina for the N-CLEX licensure exam, and CSU formed the College of Nursing to house the growth of additional graduate programs The Registered Nurse program increases again to 80 this fall and will reach 120 full-time students in January 2015 The Health Promotion, Kinesiology, and Athletic Training Departments were merged into the College of Health Sciences, and additional faculty were authorized for the increased enrollment in those programs CSU offers more than 800 courses, and approximately 140 are available online To match the needs of the local workforce, CSU has increased the number of graduate online programs in the College of Adult and Professional Studies, the College of Nursing, and the School of Business Renovations to residence halls as well as improvements to the campus infrastructure are necessary to provide the ability for continuous growth both inside and outside the classroom Additional faculty members require additional office space, library and technology support The campus computer support team continues to add bandwidth and accessibility as students demand more network services CSU continues to build partnerships with the three local school districts and averages 16 student teachers in the public schools each year Many graduates have been recognized as "Teacher of the Year" in their respective school districts There are many additional programs experiencing record growth, CSU's focus on retention strategies resulted in a higher number of students returning for their sophomore year at CSU A new Nurse Practitioner graduate program is planned for 2015 as well as expansion of the Computer Science and STEM programs The academic faculty members have been extremely involved in service to the community and regularly appear as singers and performers, as speakers at conferences, and now as hosts for national and international conferences conducted in the Whitfield Center for Christian Leadership Many of the academic programs are conducting Study Abroad programs, and CSU is actively engaged in researching cultural exchange programs for faculty and students

Student services Enrollment services, university registrar, counseling, sports, and recreation CSU has been named to the "President's Higher Education Honor Roll" for exemplary service to the community Over the past year, the University expanded the Hunter Center, added a new Leadership Development program for students, and made improvements to the University's football stadium The success is a reflection of CSU's pursuit of reaching its vision of being a Christian University nationally recognized for integrating faith in learning, leading, and serving

The governing board has specifically authorized this and recognizes it as necessary and for bona fide business purposes. The President also receives reimbursement for housekeeping and yard services due to the frequency of University guests entertained at his personal residence. Social club dues are paid for the President for the purpose of entertaining University donors, board members, etc. None of these are included in taxable compensation since they are for bona fide business purposes. The University does not have a residence on campus provided to the President free of charge as do many colleges and universities. In order to address this inequity, the governing board has authorized payment of a housing allowance to the Charleston Southern University president. This additional payment is included in taxable compensation and reported on his W-2, unlike the provision of a personal on-campus residence provided to presidents of other universities. All perquisites indicated above have been instituted by the governing board of the University.
