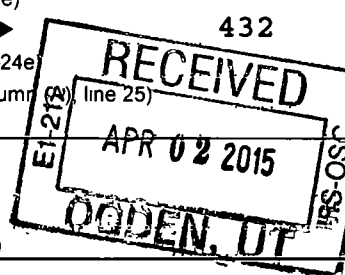

As an active volunteer organization of more than 300 women, the League has a rich tradition of providing volunteers for projects assisting women and children in the community. As part of her member requirements, each member volunteers for a done-in-a-day project with a local agency. In addition, the League looks for ways to partner with other organizations to enrich the impact of programs offered to women and children. Additionally, the League reserves a percentage of monies raised from each fundraisers and every five years awards a signature grant to a deserving non-profit agency or major League project.

The League's Strengthening Families program is dedicated to improving lives of families in the Gainesville-Hall County community, which is accomplished through League-sponsored programs focused on meeting the needs of chronically hungry children and fighting childhood obesity. The Strengthening Families program consists of three areas: Feeding our Future, Kids in the Kitchen and the Healthy Habits Expo. Feeding our Future puts food into the hands of chronically hungry children and their families through a monthly food box distribution. Each month League volunteers distribute approximately 100 boxes of food to families in need. Through interactive lessons, Kids in the Kitchen teaches children about healthy eating habits, and the Healthy Habits Expo draws nearly 600 attendees on an
