The League serves individuals in need through 38 community projects addressing a broad spectrum of needs in Houston and surrounding areas. Many of these programs are initiated by the League and fully supported through League volunteers and funding. League volunteers serve many people - infants, children, women in crisis, families and the elderly, in many places - hospitals, museums, camps and schools, and in many capacities - docents, mentors and program facilitators. During the 2013 - 2014 fiscal year, the League gave approximately \$2 million in volunteer time and direct financial support through grants, collaborative efforts and community projects
