Established in 1923, The Blue Bird Circle is a women's volunteer service organization celebrating 88 years of service to the Houston community For many years, the focus of the Circle has been to support both the treatment of children with neurological disorders, and the research into the causes and treatment of those diseases Over 500 Circle members devote at least 50,000 hours every year working in The Blue Bird Circle Clinic for Pediatric Neurology at Texas Children's Hospital or in The Blue Bird Circle Resale Shop and other fundraising activities to support the Circle's charitable causes The Shop is substantially run by the volunteer members of the Circle and provides an important source of funding to enable the Circle to support its projects The Blue Bird Foundation was created in 1951 to provide financial support for the philanthropic efforts of The Blue Bird Circle The Foundation is a 509(a)(3) Type II Supporting Organization of the Circle In 2013, the Circle transferred a portion of investment assets to the Foundation in order to maximize the growth and protection of those assets The Foundation provides part of the funding for the Circle's grants to The Blue Bird Circle Clinic for Pediatric Neurology at Texas Children's Hospital, The Blue Bird Circle Clinical Research Center at Texas Children's Hospital, The Blue Bird Circle Developmental Neurogenetics Laboratory at Baylor College of Medicine, and The Blue Bird Circle Rett Center at Baylor College of Medicine
