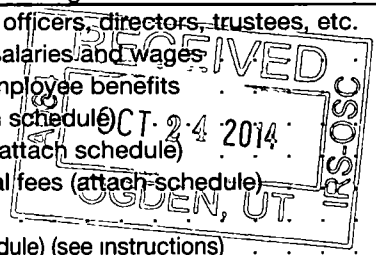

As stated above, the contribution to San Patricio County, Texas was reported at fair market value based on the above described independent appraisals.
