During the 2013-2014 year the University offered its approximately 1,223 racially and ethnically diverse students educational services in 45 different majors plus pre-professional programs in medicine, dentistry, engineering, law, pharmacy and physical therapy. The University also offers a Master of Science in Nursing in education or family nurse practitioner. The University is proud to offer a low student to faculty ratio of 12 to 1 and does not use teaching assistants in the classroom.
