NOTE B – Summary of Significant Accounting Policies

Program revenues and expenses are recorded on the cash basis of accounting which records contributions as they are received and records operating expenses as they are paid.

Membership list development costs are substantial and in accordance with generally accepted accounting principles, United Care U.S.A., Inc. recognizes these as they are incurred against operations, even though the membership list may provide significant benefit to future periods.

Fixed assets are being depreciated over 5-7 years using the straight-line method.
