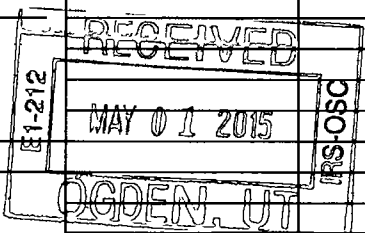

AFTER THAT, THE FOUNDATION WAS TO ENTER A QUIET PERIOD DURING WHICH IT WOULD RESEARCH AND EVOLVE A NEW MISSION. THIS IS ONGOING. THE FOUNDATION IS FUNDED ANNUALLY WITH CASH. SINCE EXPENSES WERE ANTICIPATED TO BE LOW DURING THE QUIET PERIOD, NEW FUNDING WAS NOT REQUESTED FROM ITS SOLE DONOR, ORACLE, AS IT WOULD OPERATE WITH CASH ON HAND.

THE SUBSTANTIAL DECREASE IN ASSETS WAS DUE TO EXPENDITURES ON SUNSET THINKQUEST PROGRAM AND NEW MISSION EVOLUTION, IN COMBINATION WITH THE FACT THAT NEW FUNDING WAS NOT REQUESTED.
