Explanation: I am writing to explain the late tax filings of the organization I represent. We are the Napa Band Boosters Club, Tax ID 94-6102864. We are a small organization whose mission is to provide financial and volunteer support for the Napa High School Instrumental Music program. We rely on a volunteer Board of Directors consisting of parents of children in the program. The Board members change frequently. Penalties due to late filing would be a devastating financial hardship for our organization. We did not miss the filing deadlines due to negligence, but rather the Board was given misinformation regarding the completion of filings. In the summer of 2013 a community member volunteered to provide financial book keeping support for our organization. She completed the 2012 990 to be filed in October of 2013, and the President at the time signed the taxes. In the fall of 2014 she informed the Board that she would be filing an extension for the 2013 990. Shortly after the Board became concerned that there could be other issues and asked the volunteer to return all financial files to the organization. In February 2015 the Board discovered in the files a letter from the IRS stating that the upload of the 2012 990 has failed. The Board called the IRS and discovered the 2012 990 had never been filed, and an extension for the 2013 990 also had not been filed. As soon as the Board learned about the delinquent filings, we hired a firm headed by a Certified Public Account to prepare the 2012, 2013 and 2014 990s. We have since filed the 2012 990, and with this filing, the 2013 990. We are in the process of preparing the 2014 990 and will submit it shortly. The Board recognizes the importance of filing the organization's required 990 forms correctly and on time. We have committed to continue with paying for professional tax preparation in order to ensure that the current situation we are in does not recur. Please consider waiving the late fees we are currently facing in light of our efforts to fix the situation as soon as possible. Thank you for your consideration. -- Seana Wagner, President
