THE TAHOE FUND PROMOTES THE SALE AND RENEWALS OF LAKE TAHOE LICENSE PLATES. THE FEES FROM PLATE PURCHASES AND RENEWALS GO TO TAHOE'S PUBLIC ENVIRONMENTAL AGENCIES, THE CALIFORNIA TAHOE CONSERVANCY AND THE NEVADA DIVISION OF STATE LANDS, TO FUND HIKING AND BIKING TRAILS AND WATERSHED RESTORATION. THROUGH THIS PUBLIC-PRIVATE PARTNERSHIP, THE FUND INCREASED AWARENESS OF THE TAHOE PLATES PROGRAM THROUGH A NEW CAMPAIGN CALLED "TRUE BLUE" THAT STRONGLY ASKED PEOPLE TO BUY AND RENEW TAHOE PLATES. THE CAMPAIGN FEATURED PEOPLE ENJOYING TAHOE AND ALSO FEATURED TAHOE SUPERSTARS, JULIA MANCUSO, JEREMY JONES, JT HOLMES, AND DARON RAHLVES. THE FUND WAS ALSO ABLE TO ENHANCE THE POPULAR "PLATES FOR POWDER" PROGRAM THAT REWARDS NEW PLATE PURCHASERS WITH FREE LIFT TICKETS FROM THE TAHOE SKI RESORTS WITH PLATEHOLDER APPRECIATION EVENTS AND A PLATESPOTTER CAMPAIGN.

WHILE PURSUING PRIVATE DONATIONS, THE TAHOE FUND ALSO FOCUSES ON LEVERAGING PRIVATE SUPPORT FOR CONTINUED PUBLIC SUPPORT OF ENVIRONMENTAL IMPROVEMENT PROJECTS. THE TAHOE FUND ACTIVELY PARTICIPATES IN THE LAKE TAHOE PARTNERSHIP, A COLLABORATION OF PUBLIC AND PRIVATE GROUPS IN THE BASIN THAT ARE ALL FOCUSED ON SECURING FUNDING FOR ENVIRONMENTAL IMPROVEMENT PROJECTS. THE TAHOE FUND ALSO MET WITH ELECTED OFFICIALS IN CALIFORNIA, NEVADA AND FEDERALLY TO EDUCATE ON THE NEED FOR MORE PUBLIC FUNDS. THE TAHOE FUND SPONSORED AND ORGANIZED THE 2013 LAKE TAHOE SUMMIT, A DISCUSSION OF THE IMPORTANCE OF PROTECTING AND RESTORING LAKE TAHOE. THE SUMMIT WAS ATTENDED BY MORE THAN 1,000 PEOPLE, INCLUDING THE GOVERNORS AND SENATORS OF BOTH CALIFORNIA AND NEVADA AND FORMER VICE PRESIDENT AL GORE.
