Background and History Lund's mission is to help children thrive by empowering families by breaking cycles of poverty, addiction and abuse Lund offers hope and opportunity to families through education, treatment, family support and adoption Founded in 1890, as a maternity home for unwed mothers, Lund has evolved to meet community human service needs in Vermont Our name too has evolved from the "Home for Friendless Women" to the "Elizabeth Lund Home" and more recently "Lund" Lund is the largest and oldest private non-profit adoption agency in Vermont, having finalized more than 9,000 adoptions since 1890 Lund has been for many years the only comprehensive, therapeutic residential treatment program in the State of Vermont for women who are pregnant and parenting, where they are not separated from their young children Over the years, Lund staff members have received a number of national, regional and local awards distinguishing them for their service to the community The foundation
