


NOTE A – SIGNIFICANT ACCOUNTING POLICIES

Organization

Amesbury Chamber of Commerce & Industrial Foundation, Inc. (“the Organization”) was organized in 1996 to promote the general welfare of the Town of Amesbury by actively fostering and encouraging economic and community development. Members of the Organization pay membership fees to support the Organization’s activities.

Basis of Presentation

The Organization prepares its financial statements in accordance with the Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 958 (formerly SFAS No. 117, “*Financial Statements of Not-for-Profit Organizations*”). Under FASB ASC 958, the Organization is required to report information regarding its financial position and activities according to three classes of net assets as defined below:

Unrestricted Net Assets – consist of assets, public support and program revenues, which are available and used for operations and programs. Contributions are considered available for unrestricted use unless specifically restricted by the donor.

Temporarily Restricted Net Assets – include funds with donor-imposed restrictions, which permit the donee organization to expend the assets as specified, and are satisfied either by the passage of time or by actions of the Organization. Resources of this nature originate from gifts, grants, bequests, contracts and investment income earned on restricted funds.

Permanently Restricted Net Assets – include resources, which have a permanent donor-imposed restriction, which stipulates that the assets are to be maintained permanently, but permits the Organization to expend part or all of the income derived from the donated assets.

The financial statements include certain prior-year summarized comparative information in total but not by net asset class. Such information does not include sufficient detail to constitute a presentation in conformity with generally accepted accounting principles. Accordingly, such information should be read in conjunction with the Organization’s financial statements for the year ended June 30, 2013, from which the summarized information was derived. Certain reclassifications have been made to the summarized information to be consistent with the presentation in the audited financial statements as of June 30, 2014.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Income Taxes

Amesbury Chamber of Commerce & Industrial Foundation, Inc. is considered a non-profit organization by the Internal Revenue Service under Section 501(c)(6). The organization is exempt from income taxes on revenues generated by member related activities.

Contributions

All contributions are considered to be available for unrestricted use unless specifically restricted by the donor. Contributions and grants received with donor stipulations that limit the use of donated assets are treated as temporarily restricted net assets. When the purpose of the restriction is accomplished, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions. Donor restricted contributions whose restrictions are met the same fiscal year in which the asset was received are recorded as unrestricted support or revenue.

Subsequent Events

Subsequent events have been evaluated through December 29, 2014, which is the date the financial statements were available to be issued.

NOTE B – ACCOUNTS RECEIVABLE

Accounts receivable consist of membership and special project fees. At June 30, 2014, the Organization had an allowance for doubtful accounts in the amount of \$1,650. The allowance is based on specific identification of probable losses and an estimate of additional losses based on historical experience. Account balances are charged off against the allowance when it is probable the receivable will not be recovered.

NOTE C – PROPERTY AND EQUIPMENT

Property and equipment is recorded at cost. Depreciation is provided using the straight-line method over estimated useful lives. Equipment purchases are capitalized over \$500. Depreciation expense for the year ended June 30, 2014 was \$187.

NOTE D – LOANS PAYABLE

In 2001 the Organization secured a pre-development, non-interest bearing loan of \$25,000 from the Massachusetts Development Financing Authority to seek alternative uses for certain parcels relating to a proposed development in Amesbury known as the Terrasphere project.

NOTE E – OPERATING LEASE

The Organization rents office space in Amesbury and an office copier. The office space is rented on a month-to-month basis. Future minimum lease payments on the copier are as follows:

Total rental expense was \$15,324 for the year ended June 30, 2014.

NOTE F – TEMPORARILY RESTRICTED NET ASSETS

During the year ended June 30, 2014, the Organization received contributions in the amount of \$2,000, which were restricted for the purpose of providing educational scholarships. Temporarily restricted net assets at June 30, 2014 were \$2,000.

NOTE G - RELATED PARTIES

Amesbury Chamber of Commerce & Industrial Foundation, Inc., the Amesbury Industrial Foundation, Inc. and the Alliance Charitable Foundation, Inc. (the “Charitable Foundation”) share a common Board of Directors. During fiscal 2014, the Organization collected fundraising event revenues and paid fundraising event expenses on behalf of the Charitable Foundation. At June 30, 2014, the Charitable Foundation owed the Organization \$4,718, which is recorded as “Due from related party” in these financial statements.

NOTE H -GIFT CARD LIABILITY

The gift card liability as of June 30, 2014 consisted of \$15,007 of outstanding gift cards.

NOTE I – TAX POSITION

The Organization has adopted the application of the provisions of FASB ASC 740-10 (formerly FASB Interpretation No. 48, *“Accounting For Uncertainty in Income Taxes”*). The primary tax positions made by the Organization are the existence of Unrelated Business Income Tax and the Organization’s status as an exempt organization under Section 501(c)(6) of the Internal Revenue Code. The Organization currently evaluates all tax positions, and makes determinations regarding the likelihood of those positions being upheld under review. For the years presented, and as a result of adoption, the Organization has not recognized any tax benefits or loss contingencies for uncertain tax positions based on its evaluations. The Organization’s Forms 990, *Return of Organization Exempt from Income Tax*, for the years ending June 30, 2014, 2013, 2012 and 2011 are subject to examination by the IRS. Returns are generally subject to examination for three years after they are filed.
