INDIVIDUAL RIGHTS DEFENSE PROGRAMTHE INDIVIDUAL RIGHTS DEFENSE PROGRAM (IRDP) PROVIDES ASSISTANCE TO INDIVIDUAL STUDENTS, PROFESSORS, AND CAMPUS GROUPS WHOSE FUNDAMENTAL CIVIL LIBERTIES HAVE BEEN VIOLATED. THIS PROGRAM DEFENDS INDIVIDUALS SUFFERING FROM VIOLATIONS OF THEIR FREEDOM OF SPEECH, FREEDOM OF CONSCIENCE, RELIGIOUS LIBERTY, FREEDOM OF ASSOCIATION, AND DUE PROCESS AND LEGAL EQUALITY. WORKING THROUGH OUTREACH TO ADMINISTRATORS, THE STRATEGIC USE OF PUBLICITY TO GENERATE PUBLIC ATTENTION AND PRESSURE, AND, WHEN NECESSARY, THE COORDINATION OF LEGAL COUNSEL AND ACTION IN THE COURTS, THE IRDP HAS SECURED MORE THAN 200 VICTORIES ON BEHALF OF STUDENTS AND FACULTY MEMBERS SINCE FIRE'S FOUNDING.

INDIVIDUAL RIGHTS EDUCATION PROGRAMTHE INDIVIDUAL RIGHTS EDUCATION PROGRAM (IREP) ARMS STUDENTS AND FACULTY MEMBERS WITH THE KNOWLEDGE TO UNDERSTAND THEIR RIGHTS, TO DETERMINE IF THOSE RIGHTS ARE BEING VIOLATED, AND TO TAKE THE STEPS TO CORRECT SUCH ABUSES. FIRE ALSO EDUCATES THE PUBLIC ABOUT THE STATE OF LIBERTY ON OUR NATION'S CAMPUSES, CONTINUALLY EXPOSING ABUSES OF CIVIL LIBERTIES THROUGH THE MEDIA AND ON OUR WEBSITE (THEFIRE.ORG) AND HOLDING ADMINISTRATORS ACCOUNTABLE FOR THEIR ACTIONS. FIRE'S IREP INCLUDES THE FOLLOWING PROJECTS: FIRE'S SERIES OF FIVE GUIDES TO STUDENT RIGHTS ON CAMPUS, WHICH EDUCATE STUDENTS ABOUT THEIR FREE SPEECH, DUE PROCESS, AND RELIGIOUS LIBERTY RIGHTS AND WAYS TO PRESERVE THEM, WHILE ALSO PROVIDING STUDENTS WITH THE KNOWLEDGE TO UNDERSTAND EASILY ABUSED CAMPUS PROGRAMS AND POLICIES LIKE FIRST-YEAR ORIENTATION AND PAYING STUDENT FEES; FIRE'S INTERNSHIP PROGRAM, WHICH ENGAGES UNDERGRADUATE AND LAW STUDENTS IN FIRE'S MISSION AND TRAINS THEM AS ADVOCATES FOR LIBERTY FOR EIGHT WEEKS EACH SUMMER; FIRE'S UNDERGRADUATE INTERNS ARE ALSO REQUIRED TO DEVELOP REFORM CAMPAIGNS TO BE IMPLEMENTED WHEN THEY RETURN TO THEIR CAMPUSES. FIRE INTERNS HAIL FROM THE NATION'S LEADING UNIVERSITIES AND GO ON TO REPRESENT FIRE IN HIGH-PROFILE CAREERS IN THE LAW, PRIVATE INDUSTRY, AND PUBLIC SERVICE. FIRE'S PUBLIC AWARENESS PROJECT, WHICH PROMOTES PUBLIC KNOWLEDGE ABOUT INDIVIDUAL RIGHTS, EDUCATES THE PUBLIC ABOUT THE STATE OF LIBERTY ON OUR NATION'S CAMPUSES, AND ENCOURAGES PUBLIC SCRUTINY OF OUR HIGHER EDUCATION INSTITUTIONS THROUGH ADVERTISEMENTS, MEDIA ENGAGEMENT, MULTIMEDIA AND SOCIAL MEDIA OUTREACH, AND THE DISSEMINATION OF PRINT PUBLICATIONS SUCH AS FIRE'S ANNUAL SPEECH CODE REPORT. THIS PROJECT REACHES AN AVERAGE OF 167 MILLION READERS THROUGH PRINT AND ONLINE PUBLICATIONS YEARLY AND HAS ALSO SECURED OVER 300 RADIO INTERVIEWS AND 60 TELEVISION APPEARANCES FROM 2005 THROUGH 2014. IN RECENT YEARS, FIRE HAS ALSO GAINED OVER 20,000 FOLLOWERS THROUGH TWITTER AND FACEBOOK. PROMOTION FIRE'S VIDEO INITIATIVE, WHICH PROMPTS VALUABLE DIALOGUES ABOUT FREE SPEECH ISSUES ON OUR CAMPUSES AND REACHES THE MAINSTREAM PUBLIC THROUGH THE WIDESPREAD DISSEMINATION OF SHORT DOCUMENTARIES. FIRE'S VIDEOS HAVE ATTRACTED MORE THAN 1.5 MILLION VIEWS ON OUR YOUTUBE CHANNEL, WHILE GAINING SIGNIFICANT MEDIA ATTENTION AND ELICITING PRAISE AND AWARDS.

POLICY REFORM PROJECTTHE POLICY REFORM PROJECT ENCOMPASSES FIRE'S EFFORTS TO PROACTIVELY AND SYSTEMATICALLY CHALLENGE CAMPUS POLICIES THAT VIOLATE STUDENTS' AND FACULTY MEMBERS' FUNDAMENTAL RIGHTS. THROUGH IN-DEPTH RESEARCH AND LEGAL AND PUBLIC ADVOCACY, THIS PROJECT SECURES VITAL REFORMS TO SOME OF THE NATION'S MOST EGREGIOUS SPEECH CODES. FIRE STAFF MEMBERS REVIEW THOUSANDS OF UNIVERSITY POLICIES EACH YEAR AND CHALLENGE UNIVERSITIES TO REVISE THE WORST OF THEM BEFORE THEY ARE USED TO PUNISH INDIVIDUALS OR GROUPS ON CAMPUS. BY CORRESPONDING WITH ADMINISTRATORS AND COLLABORATING WITH STUDENTS AND FACULTY MEMBERS, FIRE HAS SECURED 75 VICTORIES SINCE 1999. OVERALL, FIRE'S DEFENSE AND POLICY ADVOCACY HAS BEEN RESPONSIBLE FOR CHANGING NEARLY 140 UNCONSTITUTIONAL OR REPRESSIVE POLICIES AFFECTING ALMOST 2.5 MILLION STUDENTS NATIONWIDE. FIRE WORKS TO REVEAL AND ELIMINATE UNCONSTITUTIONAL POLICIES FROM INDIVIDUAL CAMPUSES THROUGH THE FOLLOWING PROJECTS: SPOTLIGHT. FIRE'S SPOTLIGHT DATABASE, WHICH IS A COMPREHENSIVE SEARCHABLE ONLINE DATABASE THAT CATALOGS SPEECH CODES AT MORE THAN 400 SCHOOLS, REVEALS THEM TO THE PUBLIC, AND DEMONSTRATES HOW THESE CODES ARE USED TO PUNISH SPEECH ON CAMPUS. THIS EXTENSIVE DATABASE SERVES AS A RESOURCE FOR STUDENTS, PARENTS, AND MEMBERS OF THE PUBLIC AS WELL AS FOR STUDENT, LOCAL, AND NATIONAL MEDIA. SPOTLIGHT'S DATA IS USED TO COMPILE FIRE'S ANNUAL SPEECH CODE REPORT. THIS ANALYSIS HAS RECORDED A GRADUAL DECREASE IN THE PERCENTAGE OF SCHOOLS THAT SYSTEMATICALLY VIOLATE STUDENTS' AND FACULTY MEMBERS' RIGHT TO FREEDOM OF EXPRESSION, SHOWING THAT FIRE'S RESEARCH CONTINUES TO YIELD IMPORTANT RESULTS ON CAMPUS. FIRE'S LEGAL TRANSFORMATION PROJECT, WHICH ENCOMPASSES FIRE'S EFFORTS TO ENGAGE ADMINISTRATORS AS PARTNERS IN CORRECTING POLICIES THROUGH OUTREACH LETTERS, PRESENTATIONS AT CONFERENCES, AND THE PUBLICATION AND DISTRIBUTION OF A HANDBOOK FOR SCHOOL OFFICIALS. THIS PROJECT ALSO WORKS TO INCREASE THE LEGAL INCENTIVES FOR ADMINISTRATORS TO REFORM THEIR POLICIES AND PRACTICES THROUGH THE SUBMISSION OF AMICUS BRIEFS IN STRATEGICALLY CHOSEN CASES AND THROUGH FIRE'S QUALIFIED IMMUNITY PROJECT, WHICH SEEKS TO APPLY PERSONAL LEGAL AND FINANCIAL LIABILITY FOR ADMINISTRATORS WHO ABUSE STUDENTS' CONSTITUTIONAL RIGHTS. FIRE'S LEGISLATIVE AND POLICY PROJECT, WHICH, THROUGH A UNIQUE COMBINATION OF LOBBYING, LEGAL WORK, AND PUBLICITY, COMBATS GOVERNMENT POLICIES THAT THREATEN TO ERODE FREE SPEECH PROTECTIONS AND UNDERMINE THE PROGRESS FIRE HAS ALREADY MADE ON CAMPUS. THROUGH THIS PROJECT, FIRE ALSO ENSURES THAT LEGAL PRECEDENT REMAINS STRONGLY IN FAVOR OF STUDENT RIGHTS BY BUILDING STRONG NON-PARTISAN COALITIONS AND BY STRATEGICALLY IDENTIFYING CASES TO TARGET WITH LEGAL ADVOCACY.

FIRE'S STAND UP FOR SPEECH LITIGATION PROJECTTHE STAND UP FOR SPEECH LITIGATION PROJECT IS A LARGE-SCALE NATIONAL EFFORT TO ELIMINATE UNCONSTITUTIONAL SPEECH CODES THROUGH TARGETED FIRST AMENDMENT LAWSUITS. BUILDING ON FIRE'S 100% SPEECH CODE LITIGATION SUCCESS RATE, THIS PROJECT COORDINATES LEGAL CHALLENGES AGAINST SOME OF THE NATION'S WORST POLICIES, IN CONJUNCTION WITH REFORM AND PUBLICITY EFFORTS. WORKING IN RAPID SUCCESSION AND IN MULTIPLE FEDERAL CIRCUITS, THE STAND UP FOR SPEECH LITIGATION PROJECT SEEKS TO GENERATE ADDITIONAL LEGAL PRECEDENT, WIDESPREAD MEDIA COVERAGE, AND NUMEROUS POLICY REVISIONS. ULTIMATELY, THIS PROJECT IS WORKING TO GENERATE THE PRESSURE NECESSARY TO REBALANCE THE INCENTIVES ON CAMPUS IN FAVOR OF FREE EXPRESSION. FIRE STUDENT NETWORK THE FIRE STUDENT NETWORK (FSN) IS A DYNAMIC COALITION OF THOUSANDS OF STUDENTS AND FACULTY MEMBERS DEDICATED TO ADVANCING INDIVIDUAL LIBERTIES ON THEIR CAMPUSES WITH THE AID OF GRASSROOTS SUPPORT FROM FIRE. THIS NETWORK WORKS TO SAFEGUARD LIBERTIES ON CAMPUSES NATIONWIDE BY GENERATING ON-CAMPUS REFORM, SPREADING AWARENESS AMONG STUDENTS AND FACULTY MEMBERS ON CAMPUS, AND PETITIONING ADMINISTRATORS FOR CHANGE. TO FACILITATE THIS, FIRE PROVIDES RESOURCES AND EDUCATIONAL OPPORTUNITIES FOR FSN MEMBERS, ARRANGES SPEECHES BY FIRE SPEAKERS, AND ORGANIZES AN ANNUAL SUMMER CONFERENCE. THE FSN WORKS TO CREATE LASTING CHANGE ON COLLEGE CAMPUSES THROUGH THE FOLLOWING PROJECTS: FIRE'S "KNOW BEFORE YOU GO" PROJECT, WHICH OFFERS AN ESSAY CONTEST AND CURRICULUM PACKAGE AIMED AT EDUCATING HIGH SCHOOL STUDENTS ABOUT FIRST AMENDMENT RIGHTS AND ABOUT THE STATE OF FREEDOM OF SPEECH ON COLLEGE CAMPUSES. THE FIRE STUDENT NETWORK CONFERENCE, WHICH BRINGS STUDENTS FROM ALL ACROSS THE COUNTRY TO PHILADELPHIA, WHERE FIRE REPRESENTATIVES AND ALLIES TEACH THEM ABOUT THEIR RIGHTS ON CAMPUS AND TRAIN THEM AS ADVOCATES FOR LIBERTY. FIRE'S SPEAKERS BUREAU, WHICH COORDINATES PUBLIC SPEAKING EVENTS AND ON-CAMPUS PRESENTATIONS BY FIRE STAFF MEMBERS ON KEY FIRST AMENDMENT TOPICS.
