OCEAN STATE NETWORK FOR CHILDREN AND FAMILIES - UNDER THE LEADERSHIP OF FAMILY SERVICE OF RHODE ISLAND, THE OCEAN STATE NETWORK FOR CHILDREN AND FAMILIES PROVIDES A REVOLUTIONARY NEW SYSTEM OF CARE FOR THE RHODE ISLAND DEPARTMENT OF CHILDREN, YOUTH AND FAMILIES, OFFERING A SINGLE POINT OF ENTRY INTO A BROAD ARRAY OF SERVICES THE NETWORK, WHICH INCLUDES DOZENS OF PROVIDERS, OFFERS A FULL SPECTRUM OF RESIDENTIAL AND COMMUNITY-BASED SERVICES FOR CHILDREN AND FAMILIES STRUGGLING WITH SERIOUS ISSUES INCLUDING POVERTY, SUBSTANCE ABUSE, SUBSTANDARD HOUSING AND MENTAL AND PHYSICAL HEALTH CHALLENGES WRAPPING AN ARRAY OF SERVICES ("WRAPAROUND") AROUND A CHILD AND FAMILY IS A KEY STRATEGY, AND OVERALL PROGRAM GOALS INCLUDE HEIGHTENING EFFICIENCY WHILE IMPROVING OUTCOMES FOR CHILDREN AND FAMILIES SERVED THE NETWORK'S ACCOMPLISHMENTS INCLUDE - REDUCING THE RATE OF YOUTH IN CONGREGATE CARE FROM 25% TO 21% - THIS MEANS CHILDREN AND FAMILIES RECEIVED CARE IN COMMUNITY-BASED SETTINGS AT A HIGHER RATE, WHICH IS ASSOCIATED WITH BETTER LONG-TERM OUTCOMES - PARTICIPATION IN A SUCCESSFUL FEDERAL GRANT APPLICATION WITH THE STATE TO INCREASE PERMANENCY FOR CHILDREN WAITING FOR RESOURCES FAMILIES - ESTABLISHMENT OF NEW PROGRAMS TO BETTER MEET THE NEEDS OF CHILDREN AND FAMILIES

COMMUNITY SERVICES - FAMILY SERVICE OF RHODE ISLAND CONTINUED TO BUILD UPON ITS WORK SERVING CHILDREN AND FAMILIES TRAUMATIZED BY CRIME AND VIOLENCE FOR EXAMPLE, IN THE WAKE OF A LOCAL EXTREMELY SERIOUS CIRCUS ACCIDENT, COVERED BY NATIONAL MEDIA, FAMILY SERVICE OF RHODE ISLAND'S TRAUMA AND LOSS TEAM OFFERED PARENTS GUIDANCE, VIA THE INTERNET AND NEWS MEDIA, ON HOW TO SPEAK WITH CHILDREN, PARTICULARLY VERY YOUNG CHILDREN, IN THE WAKE OF THESE TRAGEDIES AND THE WIDESPREAD AND INTENSE MEDIA COVERAGE FAMILY SERVICE OF RHODE ISLAND, REFLECTING ITS STATUS AS THE NATIONAL CHILD TRAUMATIC STRESS NETWORK SITE IN THE RHODE ISLAND AREA, CONTINUES TO BE SEEN AS A TURN-TO RESOURCE SHOULD SIMILAR TRAGEDIES TAKE PLACE IN THE FUTURE OTHER ACCOMPLISHMENTS RELATED TO CRIME AND VIOLENCE INCLUDE THE 5TH ANNUAL RHODE ISLAND STATE VICTIM ASSISTANCE ACADEMY - A COLLABORATION BETWEEN FAMILY SERVICE OF RHODE ISLAND AND ROGER WILLIAMS UNIVERSITY - WHICH TRAINED VICTIM SERVICE PROVIDERS FROM ACROSS THE STATE ON A RANGE OF TOPICS, INCLUDING VICTIMIZATION IN THE MILITARY AND WORKING WITH VICTIMS OF COMPUTER CRIMES, A DECEASED MEMBER OF THE AGENCY'S TEAM WORKING WITH VICTIMS WAS RECOGNIZED FOR HIS UNWAVERING AND OUTSTANDING DEDICATION AND SERVICE TO VICTIMS OF CRIME BY THE STATE'S ATTORNEY GENERAL AS PART OF AN ANNUAL CRIME VICTIM COMMEMORATION CEREMONY, FAMILY SERVICE OF RHODE ISLAND CONTINUED FORMAL PARTNERSHIPS WITH THE RHODE ISLAND STATE POLICE, EAST PROVIDENCE POLICE, AND PROVIDENCE POLICE TO PROVIDE SOCIAL SERVICES TO VICTIMS OF CRIME AND VIOLENCE OVER THE COURSE OF A YEAR - REFLECTING THIS PARTNERSHIP, IN A MAY 26, 2013 REPORT, THE PROVIDENCE JOURNAL HIGHLIGHTED THE WORK OF A FAMILY SERVICE OF RHODE ISLAND STAFF MEMBER WORKING WITH THE PROVIDENCE POLICE TO HELP A VICTIM OF SEX TRAFFICKING ALSO UNDER COMMUNITY SERVICES IS THE "URBAN CORE" FAMILY CARE COMMUNITY PARTNERSHIPS (FCCP), SERVING CENTRAL FALLS, CRANSTON, PAWTUCKET AND PROVIDENCE, WHICH PREVENTED OVER 95% OF SERVED FAMILIES FROM FALLING INTO THE STATE'S CHILD WELFARE SYSTEM, HELPING TO KEEP FAMILIES TOGETHER PART OF THE URBAN CORE FCCP IS "PARTNERS IN SERVICE," AN INITIATIVE JOINING TOGETHER SOCIAL SERVICES, FAITH-BASED COMMUNITIES AND BUSINESS TO HELP FAMILIES IN CRISIS MEET BASIC NEEDS SUCH AS FOOD, CLOTHING, AND THE LIKE IN THE FALL OF 2014, FAMILY SERVICE OF RHODE ISLAND'S BARBARA MARTIN, WHO CREATED "PARTNERS IN SERVICE" IN RHODE ISLAND, RECEIVED THE RHODE ISLAND STATE COUNCIL OF CHURCHES' "PARTNERS IN FAITH AWARD" FOR THIS WORK FAMILY SERVICE OF RHODE ISLAND'S AIDS PROJECT RHODE ISLAND (APRI), PART OF COMMUNITY SERVICES, PROVIDES CLINICAL AND CASE MANAGEMENT SERVICES TO INDIVIDUALS AFFECTED BY HIV AND AIDS ADDITIONALLY, APRI PROVIDES RAPID HIV TESTS TO AT-RISK INDIVIDUALS AT LOCAL COLLEGES, HIGH SCHOOLS, AND THE COMMUNITY AT LARGE BY PROVIDING INTENSIVE COMMUNITY BASED SERVICES TO OVER 400 LOW-INCOME INDIVIDUALS AFFECTED BY HIV AND AIDS, APRI HAS BEEN PROUD TO SEE ITS PERCENTAGE OF HIV POSITIVE CLIENTS WITH AN UNDETECTABLE VIRAL LOAD INCREASE TO 86% APRI CONTINUES TO LEAD EFFORTS FOR PUBLIC AWARENESS, EARLY INTERVENTION, RAPID TESTING, AND COMPREHENSIVE SERVICES FOR INDIVIDUALS AFFECTED BY HIV AND AIDS HOME-BASED PROGRAMMING AT FAMILY SERVICE OF RHODE ISLAND, PART OF COMMUNITY SERVICES, STRIVES TO PROVIDE CHILDREN AND FAMILIES IN INTENSE CRISES WITH IN-HOME SERVICES THAT FOSTER THE WELL-BEING OF THE CHILD AS WELL AS THE FAMILY AS A SYSTEM BY PROVIDING INTENSIVE CASE MANAGEMENT AND CLINICAL SERVICES, FEWER THAN FIVE PERCENT OF YOUTH NEEDED TO UTILIZE HIGHER LEVELS OF CARE, INCLUDING THE HOSPITALS PREVENTING HOSPITALIZATIONS AND OUT-OF-HOME PLACEMENTS MEANS THAT FAMILIES, WHILE COPING WITH A MULTITUDE OF CHALLENGES, ARE ABLE TO DO SO IN COMMUNITY SETTINGS THAT ARE ASSOCIATED WITH BETTER OUTCOMES ACADEMIC EXCELLENCE IS CHALLENGING WHEN BULLYING, FIGHTING AND OTHER SCHOOL DISRUPTIONS OCCUR TO PROMOTE A POSITIVE LEARNING ENVIRONMENT, THE FAMILY SERVICE OF RHODE ISLAND COMMUNITY SERVICES DEPARTMENT WORKS WITH SCHOOL DEPARTMENTS TO IMPROVE OUTCOMES FOR STUDENTS, THEIR FAMILIES, DISTRICT STAFF AND THE COMMUNITY THROUGH THE USE OF RESTORATIVE PRACTICES EDUCATORS IN RHODE ISLAND PRAISE RESTORATIVE PRACTICES FOR ASSISTING IN IMPROVED MANAGEMENT OF CLASSROOMS, FOR HELPING STUDENTS TAKE RESPONSIBILITY FOR THEIR ACTIONS, AND FOR FOSTERING A POSITIVE ENVIRONMENT THAT IS CONDUCIVE TO LEARNING AND GROWTH RESTORATIVE PRACTICES WORK!
