Youth Services FSW works with at-risk youth ages 14-22 living in the Greater Bridgeport and lower Fairfield County areas who are referred by Connecticut's Department of Children and Families We prepare individualized service plans that include intensive case management, preparation for community re-entry, work readiness and life skill training, job coaching, and placement assistance This year FSW provided 253 youth with these services resulting in 79% of 55 youth previously in placement remaining in the community, 75 youth IDA participants saved more than \$36,336 this year, with over half of the youth becoming actively engaged in the community through volunteering, internships, and/or job placements
