Connecticut Legal Services provides civil legal representation and counseling to help low-income individuals (adults and children) and families obtain just legal solutions to serious life problems. We assist our clients to use the law to help themselves climb out of poverty, improve their lives, and build better futures for their children. Our areas of practice include domestic violence/family; homelessness/housing rights; government assistance programs; employment; special education and juvenile law; elder rights, including nursing home, consumer law, and health-related issues; and disability law. During the 2013/2014 fiscal year, CLS advocates provided assistance to 3,405 low-income households consisting of 7,882 individuals, including 3,082 children. Advocates also worked on 2,048 active cases that were brought forward from the previous fiscal year. In addition, 186 outreach/community legal education events were held throughout our service area, reaching over 7,100 individuals. Over 4,800 legal educational pamphlets were distributed at these events. Connecticut Legal Services received a total value of \$224,301 in donated services during the 2013/2014 fiscal year to support the work described above. No donated office equipment having a value of \$100 or more was received during the 2013/2014 fiscal year.
