EACH MEMBER PROGRAMS BOARD OF DIRECTORS MUST SIGN A MEMBERSHIP AGREEMENT ANNUALLY. EACH MEMBER PROGRAM MUST PAY ANNUAL DUES TO CCADV BASED ON AN AMOUNT APPROVED BY CCADVS BOARD. PAYMENT MUST ACCOMPANY THE MEMBERSHIP AGREEMENT BY THE STATED DEADLINE. EACH MEMBER PROGRAM MUST SERVE A REGION IN THE STATE OF CONNECTICUT THAT IS NOT BEING SERVED BY OTHER MEMBER PROGRAMS, UNLESS SHARED TOWNS ARE AGREED UPON, TO ENSURE COMPLIANCE WITH THE FUNDING POLICY AND THE PRINCIPLES OF UNITY. EACH MEMBER PROGRAM MUST BE DESIGNATED AS A DOMESTIC VIOLENCE PROGRAM BY THE STATE OF CONNECTICUT.
