THIS PROCESS IS UPDATED ANNUALLY. IF A CONFLICT EXISTS, THE MEMBER IS REQUIRED TO RECUSE HIMSELF OR HERSELF FROM ANY VOTE INVOLVING HIS OR HER CONFLICT.

IN DETERMINING THIS COMPENSATION, THE COMMITTEE REVIEWS THE INDIVIDUAL'S PROFESSIONAL EXPERIENCE AND PRIOR SALARY HISTORY, AND REFERS TO CURRENT NY AIS, OR SIMILAR SALARY INFORMATION, AS A BENCHMARK FOR COMPENSATION FOR SIMILAR POSITIONS.
