SUPPLEMENTAL INFORMATION	<p>In July 2003, the School received proceeds of approximately \$28,000,000 from the issuance of Series 2003 Bonds by the New York City Industrial Development Agency ("NYCIDA") The monies received were used to satisfy outstanding bonds and mortgage debt of \$8,000,000, as well as to provide additional resources to complete the expansion project primarily at the School's West End Avenue location in New York City The proceeds also provided funding for improvements to other School facilities and for the acquisition of furnishings and equipment at each of those facilities In June 2006, the School completed an additional NYCIDA bond issuance, for approximately \$5,500,000 The proceeds from these Series 2006 Bonds were used (i) to fund an approximate \$3,100,000 settlement agreement with a construction management company, in connection with the expansion project and renovation of the West End Avenue building, and (ii) for supplemental financing necessary to cover construction cost-overruns incurred in connection with the expansion project With the addition of the Series 2006 Bonds to the Series 2003 Bonds (together, the "Bonds"), the existing agreements between the School and the NYCIDA were amended accordingly Interest expense incurred for the Bonds during fiscal-years 2014 and 2013 amounted to approximately \$1,848,000 and \$2,014,400, respectively In September 2013, the School borrowed approximately \$33,000,000 under a mortgage note payable to the First Republic Bank, at an interest rate of 3.65%, with a portion of the proceeds to be used to discharge the debt associated with the outstanding Bonds However, under the terms of the respective Bond indentures, neither series of Bonds can be retired before specified redemption dates Accordingly, a trust agreement was formed in September 2013 that established irrevocable escrow funds with sufficient financial assets to pay all interest and principal on the Bonds as they come due Although the School's cash obligation for the redemption of the Bonds has been satisfied, a portion of the funds held in escrow represents prepaid interest which will be subsequently recognized as interest expense (partially offset by the earnings on the funds held in escrow) in each of the fiscal years prior to the Bonds' maturity dates All cash interest payments made subsequent to September 2013 are thus made from the escrow funds and not directly from the School Interest expense on the Bonds in fiscal-year 2014 was \$498,531 for that portion of the fiscal year prior to the borrowing from First Republic Bank and the establishment of the escrow funds in September 2013 and was \$1,350,281 for the remainder of the fiscal year In fiscal-year 2013, interest on the Bonds was \$2,009,359 Principal payments on the bonds will be made according to the following schedule Year Ending June 30 Amount 2015 \$22,305,000 2016 105,000 2017 4,755,000 ----- \$27,165,000 ===== Annual payments for the mortgage note payable to First Republic Bank are expected to be made as follows Year Ending June 30, Amount 2015 \$624,790 2016 645,095 2017 672,590 2018 697,907 2019 724,177 Thereafter 29,073,775 ----- \$32,438,334 =====</p>
