Over the past 145 years, The Foundling has evolved from a respite home for abandoned children, to a comprehensive spectrum of community services in support of our mission to empower children and families to live healthy, independent, and fulfilling lives. Our vision is a community where every person, regardless of background and circumstance, enjoys the safe, stable, and supportive relationships needed to reach his or her full potential. The Foundling directly serves over 7,000 families in all five boroughs of New York City, Rockland and Westchester counties, and Puerto Rico, and recently expanded our reach to an additional 20,000 children by joining forces with the Child Abuse Prevention Program (CAPP). Our programs respond to a wide variety of needs and support children and families who struggle with o
