My Sisters' Place offers emergency residential services to victims of domestic violence and human trafficking and their dependent children, providing temporary housing and advocacy on their behalf. During the fiscal year ended June 30, 2014, the shelters provided 11,793 bednights to 173 adults and 185 children. Our 24-hour crisis hotline, where victims can receive emotional support, information, referrals, and access to shelter services, engaged with 2,961 callers during the fiscal year. Through creative art activities and therapeutic play, residential counselors create a safe environment for children housed in the shelters to express their feelings. The shelter staff conducted 5,912 individual counseling. See Form 990, Page 2, Part III, Line 4a (continued)

My Sisters' Place offers non-residential services to victims of domestic violence and human trafficking and their dependent children. Non-residential services include individual and group counseling, child care, and self-sufficiency training. Through non-judgmental supportive services, we aim to create a safe environment where we can help our clients empower themselves to make healthy choices that will benefit the emotional and physical well-being of themselves and their children. We strive to help clients identify the red flags of abuse, increase positive self-esteem, and provide relevant resources and options. We also conduct ongoing personalized safety planning with each client who engages in. See Form 990, Page 2, Part III, Line 4b (continued)

My Sisters' Place offers free legal services in the areas of family law and immigration law to victims of domestic violence and human trafficking and their dependent children. Legal services include direct representation of clients in court, legal advice and counsel, and administrative advocacy. With the goal of keeping both clients and their children safe, our family law attorneys and advocates assist victims in both the civil and criminal courts with Orders of Protection and on custody matters. Our immigration team provides legal services to undocumented victims by advocating for and securing their legal status in the United States. Our Self-Sufficiency Program helps victims overcome barriers to education and employment through goal planning, skill-building workshops, and referrals to employment and education. During the year, 257 clients were served, who received over 864 counseling sessions to enable achievement of their goals. The Human Trafficking Program serves victims of sex and labor trafficking, including victims of any age, gender identity, and immigration status. During the year, we provided direct services and/or technical assistance on 73 cases of human trafficking. MSP is a co-founder of the Westchester County Anti-Trafficking Task Force, a group of federal, state, and local law enforcement and service providers who convene to increase the number of investigations into trafficking cases and ensure appropriate referrals and service provision for victims.
