**RESEARCH and DATA ASSISTANCE**

American Community Survey Data User Group Annual Conference: The first American Community Survey (ACS) Data Users Conference was held on May 29-30, 2014. Helped to plan the conference as a member of the ACS Data Users Group Steering Committee. Howard also was a moderator for a session on using the ACS to look at small population groups and trends over time. Nearly 300 attendees from around the country attended the conference. More information about the conference and the data users group can be found online at: <http://www.acsdatausers.org/>

Census Information Center Virtual Training Conference: Due to budget cutbacks, instead of an in-person training conference for the CIC Program participants, the Census Bureau organized a virtual training conference this year using webinar software. As part of this conference, the Federation presented our use of GIS and Census data in creating our profiles of the new legislative and city council districts. The profiles summarized the changing Asian ethnic populations of New York City and the wide range of languages spoken in our communities.

Conversations with the Census Bureau regarding future Census from questions on race and ethnicity: The Asian American Federation, in partnership with the National Council of Asian and Pacific Americans, Asian American for Advancing Justices, and a group of Asian American academics, have been in on-going conversations with the Census Bureau staff in charge of reevaluating and redesigning the race and ethnicity questions for the 2020 Census and the ongoing American Community Survey. Evaluations of potential format for those questions revealed that the certain formats would result in a decline in the data quality for Asian respondents.

AAFE Conference: At this year's Asian Americans for Equality's 7th Annual Asian American Community Development Conference, the Federation was a panelist at a workshop entitled Measuring Outcomes in Community Development: Big Data and On the Ground. Howard discussed the ways national data set can be used at the community level and addressed some of the issues and limitations of working with the data for Asian and immigrant communities.

New York City Asian Senior Report: Finished the preliminary data collection for this local report, located all the member agencies providing senior services and citywide senior centers, and researched on potential senior service funding.

CSAAH Training on using Census Bureau data for community-based research: The Federation ran a training session for new summer interns for NYU's Center for the Study of Asian American Health. The training session covered the types of data that the Census Bureau provides on communities, how to access the data and the issues and limitations of the data sets. The training sessions occurred on July 9, 2013 and June 24, 2014.

GIS Basic Training for Census Information Center Network: On September 25, 2013, the Federation's CIC staff held a training webinar on how to use the GIS software to create maps using Census Bureau data. The Census Bureau provided the technology to hold the webinar and the Federation presented the actual training.

Data requests: Provided information to various community leaders on the NYC APA community on economic information for congressional testimony, poverty rates in Chinatown for legal experts, and advocates on NJ ethnic breakdown.

**PUBLICATIONS**

A Community of Contrasts: Asian Americans, Native Hawaiians, and Pacific Islanders in the Northeast: In partnership with Asian Americans Advancing Justice - Los Angeles (AAAJ-LA), the Asian American Federation released a demographic report on Asian Americans, Native Hawaiians, and Pacific Islanders that covered the northeastern United States, with specific focus on the Boston, New York, and Philadelphia metropolitan areas. The Federation and AAAJ-LA also hosted a launch event on November 21, 2013 at the Asian Society. The report highlights were presented and panel discussed the implications of the demographic changes in the Asian communities of the Northeast.

State of Asian American Children: The Federation released our State of Asian American Children on March 27, 2014 in conjunction with our national children's conference. The report covers the demographic changes that have occurred over the last decade among Asian American children. Additional topics include education, health, family structures, languages abilities, and economic circumstances. We conclude with a section of policy implications to tie together the common themes that emerge from this report.

**CONVENINGS & MEETINGS**

State of Asian American Children's Conference: The Federation held the first national conference on Asian American children on March 27, 2014 at the Time Warner Center. Almost 200 people participated in a full day of speakers and on topics ranging from education policy, to health care, to the challenges of growing up Asian American.

Community Groups Meetings: In order to seek advices to update our NYC senior report and create a working group, AAF has been meeting with member agencies serving APA seniors.

NACAPCD: Attended the national convention. Coulter Foundation: Attended the annual APA leadership convening. WK Kellogg Foundation: At the request of the Foundation's leadership, attended convening of the national grantees working on English Language Learners integratio issues.

**DEVELOPMENT**

The Spirit of Asian American Gala 2014 was held on June 18th at the Pierre. The event afforded us the opportunity to celebrate our Asian American communities with our corporate diversity partners, supporters, and friends. This year's honorees were: Stella Aquino, Kyung Hee Choi, Don Lowery, and Ted Teng.

Asian Pacific Islander Network at KPMG: AAF hosted member agencies and community needs to the APIN network to promote volunteerism, encourage philanthropy, and inspire young professionals to 'give back' within their communities.

Individual donor cultivation meetings(breakfast, lunches, dinners, coffees).

Attended workplace campaign events, public service career expos, and other workshops to introduce AAF and/or solicit workplace campaign funding. For the 2013-2014 fiscal year, almost \$25,000 of funds were collected for AAF from CUNY's Campaign for Voluntary Charitable Giving (City University of New York); Combined Municipal Campaign (New York City employees) and State Employee Federated Appeal. Distribution is based on the total of designated gifts made to specific member agencies plus the equal share of underdesignated portions, minus administrative costs for the United Way of New York City, who manages these annual public sector campaigns. AAF was proud to provide its member agencies an additional funding stream last year.

Meeting with Commissioner Donna Corrado of NYC Department for the Aging with community groupus to introduce members agencies providing senior services and raise Asian community concerns.

Municipal ID Legislation: Convened meeting with Commissioner Nisha Agarwal of the Mayor's Office of Immigrant Affairs about the progress and concerns of Municipal IDs.

Meeting with Commissioner Nisha Agarwal of the Mayor's Office of Immigrant Affairs: Member agencies met with the Commission to discuss Asian American community issues and solutions.

In partnership with Congresswoman Grace Meng, hosted the first annual APA Policy Table for APA Heritage Month. The event's objective was to convene federal, state, and local elected leaders, corporations, nonprofit, and community leaders, and other stakeholders to discuss the development of APA small businesses and the purchasing power of Asian New Yorkers.

The Federation is a member of the newly-formed Civic Participation project, organized by mainstream organization in NYC, to engage female voters in key NYS elections. The Federation's role is to bring the APA voice to funders and decision makers.

Serve in an advisory capacity to the NYC Department of Health on disaster preparedness.

**CITY LEADERSHIP**

Meetings with new City Leadership to discuss the appointment of more APA leaders to city posts, changing demographics, community needs and challenges, and new program ideas.

Met with new NYC Dept of Youth and Community Development Commissioner to request new programs to support the growing APA population, and for support with city-wide contract reform to enable newcomer groups serving emerging communities to access city funding.

Hosted a meeting with NYC Council member Margaret Chin, the new Council chair on Aging with over 15 community agencies to discuss the issues impacting service, needs, etc. Provided testimony at the City Council hearing on the Aging.

The Federation, as a member of the Communities of Color CBO Coalition comprised of four Black, Latino, and Asian federations, requested a \$10 million dollars earmark from the City budget to assist small nonprofits to build organizational capacity to compete with larger groups in the city contracting process, as well as request a reform to the contracting process itself to give agencies with cultural and linguistic expertise extra points on the city's RFP process. The Coalition was awarded \$2.25 million for the nonprofit stabilization fund.
