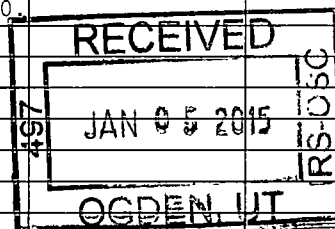

WHEREAS, Article VII of the Trust provides that the Trust can be amended by unanimous vote of the Trustees; and

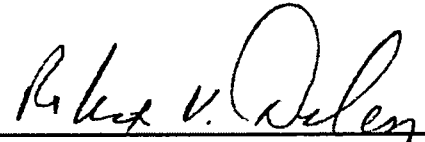
WHEREAS the undersigned Trustees wish to change the name of the Trust.

The Trust is hereby ratified and confirmed in every other respect.

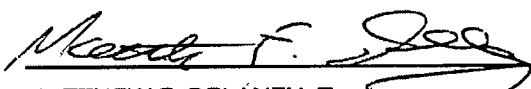
