Demos Freedom to Vote team works to strengthen our democracy and increase access to the ballot for our multi-origin, multi-racial citizenry. Our work to achieve this includes increasing voter registration of low-income people by enforcing the public agency provisions of the National Voter Registration Act, expanding the freedom to vote by advancing pro-voter election reforms, anchored by Same Day Registration, shifting popular opinion to reverse or halt measures that restrict voting rights, and addressing structural barriers to fair redistricting and representation.

Demos New Economic Paradigms Team (previously Business In Society) is focusing on a new role for business in society. We envision a world in which democracy writes the rules for capitalism, not the other way around where people have the power to set expectations for the way business operates in an interdependent society. And we are promoting an expanded view of progress beyond growth alone, recognizing that the well-being of our people and our planet are poorly captured and poorly served by a singular focus on GDP.

We seek to end the debt-for-diploma system by advocating for debt relief for borrowers, addressing the causes of declining affordability, and exposing the role of Wall Street in the financialization and privatization of higher education.
