The camp exposed kids to music, visual art and contemporary dance. DASSdance summer intensive gives pre-professional teens the chance to work with world class dance masters and learn DASSdance repertoire. In addition to on-going classes for DASSdance School, Artistic Director Daniel Wilkins, along with dancers from the company, taught contemporary dance as part of the Leschi Elementary After-School Program. DASSdance developed and premiered "Tale of Ten Green" at Seattle's Washington Hall in partnership with Survival International. DASSdance brought exposure to the struggle of the Awa tribe in Brazil and contributed 50% of proceeds from a Gala benefit in their honor. "Mini Nutcracker Santa Breakfast" played to sold out crowds at Washington Hall, Seattle. Foster families from Casey Family Programs attended for free.
