Primary Exempt Purpose:

The Peace Appeal Foundation works to catalyze social change processes designed to reduce violent conflict and lay the groundwork for sustainable, just peace. To this end, we engage with individuals, institutions and communities in societies in conflict (from senior political leadership, to religious and civil society leaders to community groups and local citizens) as well as international partners to develop the processes, programs, structures and institutions that will support the transformation of their conflicts. We also seek to help improve the practice of peace building more broadly through research, education and other initiatives to enhance the understanding and effectiveness of peace initiatives globally.

PROGRAM SERVICE ACCOMPLISHMENTS – FY 2014

The Peace Appeal Foundation continues to provide technical assistance, financial support and in-kind contributions to stakeholders and national institutions supporting dialogue and peace efforts in the Middle East and Southeast Asia. As in the previous year, our focus has been on aiding the Beirut based Common Space Initiative for Shared Knowledge and Consensus Building and emerging efforts among stakeholders in Myanmar/Burma to engage in a national peace and dialogue process.

The Beirut based Common Space Initiative (“CSI”) continues to support several national dialogues among Lebanese stakeholders, including specific dialogues focused on political reform issues, judicial reform and Lebanese Palestinian relations. The CSI hosts regular meetings, providing facilitation and research support offered by its resident staff and network of partners. The CSI also continues to provide technical support to various entities of the Lebanese government to aid in strengthening Lebanon’s constitutional structures. In its work the CSI is aided by the Peace Appeal’s co-founder, who serves as the resident technical adviser.

In addition to its focus on efforts to strengthen Lebanon’s constitutional systems, the CSI also hosts several regional efforts, including one to improve mediation, facilitation and support of political reform efforts in the Middle East, and has also been a core partner in a broader coalition with the Peace Appeal that is working to develop knowledge resources and improve the state of practice in the development of national dialogue processes and structures.

This later effort includes a project to develop the new knowledge resource known as the Peace and Dialogue Platform to be launched in the coming year. The Peace Appeal mobilized teams of researchers, both in the US and internationally, to curate information relevant to peace and dialogue processes which will be integrated into the platform.

To support the coalition's work studying and developing new resources on national dialogues and their supporting institutional structures, the Peace Appeal served as a co-organizer of the first international conference on "National Dialogues and Mediation Practices" hosted by the Finnish Foreign Ministry, held in Helsinki in March and April of this year. The conference brought political, religious, and civil society leaders from many countries together to discuss national dialogues process past, present and future, examining experiences and prospects in South Africa, Yemen, Myanmar/Burma and Syria. A second conference is planned for 2015.

The Peace Appeal's efforts in Myanmar included technical assistance provided by our senior technical adviser and associates to the stakeholders in the region as they plan for the national transitional political process that will lead to a new constitution for the country. Additionally we provided small grants to assist in the development of the knowledge resources for the Pyidaungsu Institute, which officially opened its doors this past year as a peace structure to support Burma's ethnic groups' participation in the country's peace and political reform process.
