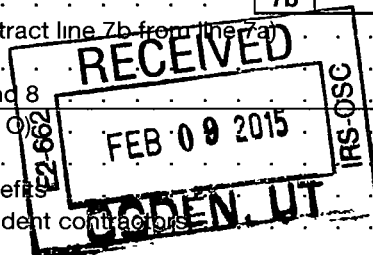

Pemsoft is a vast, powerful electronic knowledge system with thousands of topics, interactive modules and an extensive library of photographs, drawings and videos. PEMSoft software is a constantly updated, multi-media, state of the art pediatric knowledge system licensed commercially in the USA and Western world. The software is available as a mobile app for smartphones which is downloadable to the native memory of the phone (no need for internet access or electricity), as well as a Web app. KidsCareEverywhere donates the software and trains doctors and medical professionals primarily with the mobile app. The CD version is being discontinued.

The Fair Market Value (FMV) of this contribution is based upon the licensing revenues received commercially in the USA and the Western world.

In general, the FMV of a large hospital setting is \$50K per site, for a smaller hospital, the FMV is \$15K. Individual licenses at FMV are \$150 each.

The cumulative FMV of the PEMSoft licenses received and distributed during the fiscal year ending June 30, 2014 is \$92,300.

Program Training and Distributing Medical Software to Eight Sites in Developing Countries

KidsCareEverywhere is a 501(c)(3) public charity dedicated to transforming pediatric care in under-resourced communities by enabling doctors to care for sick children more effectively. Further information can be seen at www.KidsCareEverywhere.org

KidsCareEverywhere helps impoverished children in the developing world through integrating information technologies into everyday healthcare delivery systems. We do this by donating software called PEMSoft and training doctors and medical professionals in their use. Software is constantly updated, multi-media, state-of-the-art pediatric knowledge system licensed commercially in the USA and Western world. The software is available as a mobile app for smart phones which is downloadable to the native memory of the phone (no need for internet access or electricity). KidsCareEverywhere donates and trains doctors primarily with the mobile app. PEMSoft is gifted to KidsCareEverywhere by EBSCO Health, Ipswich, Massachusetts.

During the fiscal year 2013-2014, KidsCare Everywhere visited and trained doctors and medical professionals in 8 worldwide locations in the developing world. KCE members donated over 600 hours in the field to provide the following services in the following developing countries:

1- Vietnam: training took place primarily at National Hospital of Pediatrics in Hanoi, during March-May 2014. Training was done by 9 KCE team members.

More than 18 formal training sessions were held, plus numerous informal individual sessions performed by 2 KidsCareEverywhere interns who stayed for 3 months. Over 252 doctors and medical professionals were trained in using PEMSoft. Distributed 252 PEMSoft Portable and web copies to users.

2- Cambodia: training took place at Angkor Children's Hospital in Siem Reap City, Cambodia during March 2014. Training was done by 7 KCE team members. Three training sessions were held, forty doctors and medical professionals were trained in the use of PEMSoft. Distributed 40 PEMSoft portable and web copies to users.

3-5- Africa (Senegal, Morocco, Namibia): training took place in various hospitals during July-August 2013. Training was done by 1 KCE team member. Fifteen training sessions were held, 60 doctors and medical professionals were trained in using PEMSoft. Distributed 60 PEMSoft CD copies to users.

6- Kenya: training took place at the Matibabu Foundation Hospital in Ukwala, Kenya during May 2014. Training was done by 2 KCE members. Three training sessions were held, 9 doctors and medical professionals were trained in the use of PEMSoft. Distributed 16 PEMSoft Portable copies to users.

7- Ecuador: training took place at various sites within the Amazon Basin in Ecuador, during June 2014. Training was done by 3 KCE members. Two formal training sessions were held, 21 doctors and medical professionals were trained in the use of PEMSoft, along with numerous local doctors in informal training sessions. Distributed 21 PEMSoft Portable copies to users.

8-Haiti: training took place at the Tallahassee-Haiti Medical Clinic in Campeche-Dumay, Haiti, and King's Hospital in Port-au-Prince, Haiti during May-June 2014. Training was done by 1 KCE team member. One training session was held, 1 doctor was trained in the use of PEMSoft. Distributed one PEMSoft Portable copy to user.

In summary, KidsCareEverywhere visited and trained in 8 countries, conducted 42 formal training sessions, trained over 383 doctors and medical professionals, distributed over 390 PEMSoft copies to users. In addition, software for hospital servers was provided in Vietnam, Cambodia, and Kenya.
