 RCN Center City RCN Center City is our satellite location in the historic Sibley Building in downtown Rochester This site has the capacity for 35 children, ages 6 weeks through 4 years Since the site opened in early 2014, RCN Center City served 34 children, and included a pilot program called Summer LEAP, designed to address summer learning loss in preschoolers Our Nurturing Communities program is designed to enable two generations of low income families to achieve economic self-sufficiency The program targets a group of young mothers living in poverty, provides practical vocation training on site in a child care setting, utilizing partnerships with Family Child Care Satellites of Greater Rochester, Work Experience Program (WEP) Interns earn their Child Development Associate credential In addition, WEP Interns are paired with experienced teachers in a mentoring relationship, and a social worker supports them with problem solving The goals of the program include helping parents learn the foundations of child development, contributing to sound parenting and skills that allow for a meaningful career in child care and teaching In addition to program revenue above, this program is supported by government contributions of \$237,179
