Aschiana Foundation partnered with American Medical Overseas Relief to convert a wing of the Kabul Children's Center into a clinic to support the children and their families. The clinic began seeing patients in May 2013 and has seen anywhere from 200 to over 600 patients per month. Health classes are also provided. Aschiana helps fund the operating costs of the clinic, including the salary of a biomedical technician (trained in the US).

Aschiana Foundation supports the primary programs of providing educational and vocational skills, as well as nutritional meals and classes on health and sanitation to the working street children of Afghanistan through the Afghan charity, Aschiana. More than 7,000 children are being served at 16 centers located in Kabul and other provinces in Afghanistan. During the current year, funding from Aschiana Foundation provided specific student educational support (through a sponsorship program) as well as general support to Aschiana's educational, vocational, food and health programs. Additionally, heating materials, clothing and blankets were provided to help families through the winter.

Aschiana Foundation helped pay down the mortgage of the children's center in Kabul. This center was completed in May 2011 and is the permanent home of the Afghan charity, Aschiana, in Kabul.
