In the case of FIRST robotics, FIRST (EIN Number 22-2990908) is the primary organization operating FRC robotics in United States and was the primary organization to run the Midwest Regional FRC championship. Inscite Illinois received a donation from the Boeing corporation to fund the program in Illinois and this \$25,000 donation was granted to FIRST to help fund the Midwest Regional.

For the individual teams Inscite Illinois provides receives funding with some limited restrictions to fund individual teams. Teams are provided grants after providing receipts showing matching expenses for their robotics team. Often this funding involves teams chosen to attend national or international championship tournaments. Inscite Illinois separately tracks the restricted donations and provides grants only after receiving evidence of expenses related to robotics education. The restrictions are time bound and after one year Inscite Illinois is free to use the funds as unrestricted contributions should teams not demonstrate expenses used for robotics education.
