The DRIVE4COPD campaign is a landmark public health initiative of the COPD Foundation that aims to raise awareness of COPD, drive earlier diagnosis through risk screening, champion access to needed care and services, and advance efforts to help people with COPD live full and productive lives. The campaign is working to help individuals determine their risk and recognize the signs and symptoms of COPD so they can be empowered to take action. The campaign has partnered with NASCAR, which has adopted the DRIVE4COPD campaign as its official health initiative

The COPD Biomarkers Qualification Consortium's mission is to implement the qualification of public domain biomarkers that assist in the development and registration of treatments for COPD with the FDA. The current members of the Consortium are actively working with several academic centers, the NHLBI and the COPD Foundation to identify and publish key biomarkers

The Foundation's educational programs are designed to empower those living with COPD to take charge of their health management and to provide health care professionals with tools to improve patient care. The goal of these educational efforts is to improve the quality of life of those affected by COPD. The Big Fat Reference Guide is a comprehensive resource guide developed by the COPD Foundation. The 400+ page Guide was written for people with COPD, their families and caregivers. However, it is also widely used by health care professionals for patient education. The BFRG contains three sections: Managing your health, Managing your disease, and an appendix with useful forms and worksheets. The Slim Skinny Reference Guide is a series of 10 of the most salient topics from the Big Fat Reference Guide
