Schedule L, Part V Supplemental Information	Bob Arceci, M D of Phoenix Children's Hospital is principle investigator for a consortium grant made to a group of six research institutions for a grant entitled "Pathway Directed Treatment for Refractory AML " He is one of twelve researchers included in the budget of this project This grant was awarded through the St Baldrick's Foundation's normal scientific review process Three childhood cancer research experts review each application, and reviewers cannot be from the same institution as the applicant (in the case of a consortium grant, this includes all of the participating institutions) and cannot have a personal relationship or other conflict of interest with the applicant or project Each reviewer answers a standard set of questions and gives the application a score, using the NIH (National Institutes of Health) rating system Once all three reviewers have scored an application, they may discuss any differences or concerns they have with each other Applications with scores that are widely divergent or are close to the expected funding cut-off are discussed in a committee made up of all the reviewers for applications in this grant category, and each participating committee member gives the application a score at the end of that discussion The average score is used for final funding recommendations The board of directors votes to approve grants above a specific score, depending on funds available Dr Arceci recused himself from the board discussion involving his funding category, and a former board member and researcher answered all questions at the board meeting regarding that funding category Dr Arceci also recused himself from the board's vote on this funding category
