NOTE A. Organization and Funding

Organization

He Opens Path to Everyone, Inc. (H.O.P.E.) is a Christian ministry to assist those without sufficient resources to provide for their own basic needs in Anne Arundel County, Baltimore City and the Appalachian Region.

Effective January 1, 2012, the Organization elected to change its year end from December to June.

Funding

The operations of H.O.P.E. are funded principally through contributions and grants from individuals, businesses, governments and foundations.

NOTE B. Summary of Significant Accounting Policies

Basis of Presentation

The Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

Cash and Cash Equivalents

H.O.P.E. considers all highly liquid investments with a maturity date of less than three months from the date of purchase to be cash equivalents.

Contributions

Contributions are recorded as unrestricted, temporarily restricted or permanently restricted net assets depending on the existence or nature of any donor restrictions.

Donated Goods

For the year ended June 30, 2014, H.O.P.E. recognized contributed merchandise with a fair value of \$205,365 as contribution revenue.

Inventory

Contributed inventory is valued at fair value using estimates, averages and computational approximations applied on a consistent basis. The inventory measurement process considers fair value of contributed inventory to be the equivalent of cost of goods sold. Purchased inventory is stated at cost.

Advertising

The costs of advertising are expensed as incurred and amounted to \$200 for the year ended June 30, 2014.

Property and Equipment

Property and equipment are stated at cost and depreciated over the estimated useful lives of respective assets using the straight line method.

The estimated useful lives of the assets are as follows.

Vehicles	5 years
Office furniture and equipment	5 years

Additions, renewals and betterments are capitalized whereas expenditures for maintenance and repairs are charged to operations. The cost and related accumulated depreciation of assets retired or sold are removed from the appropriate assets and depreciation accounts and the resulting gain or loss is reflected in operations.

Promises to Give

Contributions are recognized when the donor makes a promise to give to the Organization that is, in substance, unconditional. Contributions that are restricted by the donor are reported as increases in unrestricted net assets if the restrictions expire in the fiscal year in which the contributions are recognized. All other donor-restricted contributions are reported as increases in temporarily or permanently restricted net assets depending on the nature of the restrictions. When a restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets.

Income Tax Status

H.O.P.E. is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code and, accordingly, no income taxes are provided in the accompanying financial statements.

The Organization's Forms 990, *Return of Organization Exempt from Income Tax*, are subject to examination by the IRS, generally for three years after they were filed.

Use of Estimates

In preparing financial statements in conformity with generally accepted accounting principles, management is required to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Concentration of Credit Risk

H.O.P.E. maintains its cash balances with various financial institutions located in the Baltimore, Maryland area, which, at times, may exceed federally insured limits. H.O.P.E. has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on its cash and cash equivalents.

Functional Allocation of Expenses

The costs of providing various program and supporting services have been summarized on a functional basis in the Statement of Activities. Accordingly, certain costs have been allocated among the program and supporting services benefitted.

Date of Management's Review

Management has evaluated subsequent events through January 7, 2015, the date on which the financial statements were available to be issued.

NOTE C. Commitments

The Organization rents three warehouse spaces on a year-to-year basis. The monthly rental is \$3,383 plus utilities. Rent expense for the year ended June 30, 2014 was \$39,339.
