

July 1, 2013 - June 30, 2014

Bright Futures operates a child care resource and referral service for Montrose, Delta, San Miguel and Ouray counties. This fiscal year we had 20 phone referrals (Bright Futures no longer does referrals from our office – calls have been consolidated and are answered by Mile High United Way in Denver). Bright Futures and Mile High United Way have been in contact and are working together to ensure parents will continue to receive up-to-date information for local resources). Bright Futures had 910 internet referrals to help parents find quality child care in their area. Bright Futures (BF) also provided 25 teacher trainings and 278 child care providers attended. This enabled them to obtain the 15 hours each, of continuing education credits required by state licensing regulations. BF delivered a total of 76.50 hours of provider education.

Bright Futures home tutoring program for parents and children ages birth to 8 called Parents as Teachers (PAT) had 90 families participate this fiscal year, 505 home visits were conducted for 128 children to prepare them for success for their first day of kindergarten. The parents also gained parenting skills.

Bright Futures awarded \$4,433.50 in educational stipends to teachers and caregivers pursuing degrees and professional development (college courses) in Early Childhood Education. Bright Futures also provides financial assistance to providers for educational materials.
