Asylum Access' mission is to make refugee rights a reality in Africa, Asia and Latin America. We achieve this mission by transforming the human rights landscape for refugees in first countries of refuge, using five core tools: legal aid, community legal empowerment, strategic litigation, policy advocacy, and movement building.

Legal aid: Asylum Access's legal advocates provide direct legal assistance to help asylum-seekers obtain refugee status, the first step to accessing all other rights in a country of refuge, ensuring they are not wrongly denied and have access to due process. In addition, we help refugees access other rights, such as the right to work, and respond to rights violations, such as owed wages and labor disputes. This year, we continued to respond to a high demand for legal aid by refugees and asylum seekers, serving over 15,000 refugees in Ecuador, Tanzania and Thailand through legal information, advice, counsel and/or representation. Our work shows high success rates; the Refugee Status Determination (RSD) cases we represented this year in Ecuador, Tanzania and Thailand had higher success rates than the national average in each country. This year we also defended the right to work for refugees in Ecuador, providing legal services to 936 people pertaining to their right to a safe and lawful livelihood.

Community Legal Empowerment: Community Legal Empowerment, through Know Your Rights and Know Your Options workshops, helps refugee to understand their rights and how to assert them. Refugee leaders receive training to provide basic legal assistance to

others in their communities, and launch their own social justice initiatives with our support. To facilitate self-sufficiency, we organize refugee work rights workshops and women's empowerment groups. This year we reached approximately 5,500 refugees through Know your Rights training workshops in all countries, with specialized training on work rights in Ecuador. In Tanzania, 210 refugees were reached through Junior Achievement entrepreneurship trainings to help them access livelihoods, and Women's Empowerment Groups which help refugee women build resilience. In Ecuador over 250 women participated in Women's Empowerment Groups. In Thailand, 20 refugee interpreters were trained to help other refugees access legal aid in their native languages.

Policy advocacy: Policy advocacy and government engagement allow us to transform laws and practices so that entire refugee populations can enjoy their rights automatically. Our policy advocacy at the national and international levels affected over 1,000,000 refugees worldwide. In Thailand, we helped draft an amendment to the national Immigration Act, which would offer an alternative to detention for refugees, who are currently offered no protections by the government. Our advocacy in Southeast Asia also led to the inclusion of the right to asylum in the Association of Southeast Asian Nations (ASEAN) Human Rights Declaration. In Tanzania, we made major strides towards the passage of an urban refugee policy that would allow refugees to live and work outside camps. The Ecuador office led regional efforts to improve due process in RSD proceedings, drafting a report for the Inter-American Commission on Human Rights on the status of refugee rights in the region. Globally, Asylum Access continued to advocate for work rights for refugees, growing our Right to Work campaign and coalition, which conducted a groundbreaking investigative survey and drafted the Global Refugee Work Rights report, which was

We use strategic litigation to bring test cases before national and international courts, so that refugees may enjoy their rights automatically without having to fight for them. Finally, Asylum Access continues to work to expand the reach of our services, building a global movement for refugee rights. We laid out a plan for expansion into new countries, and laid the groundwork for the launch of new offices in Malaysia and Panama in the coming fiscal year. The Refugee Rights Toolkit, an online office-in-a-box combined with an individualized mentoring program, plays a key role in our strategy to identify and cultivate new international leaders in the refugee rights movement; this year we added gender sensitivity materials and strengthened the mentorship component, coaching 2 refugee rights leaders in India and Indonesia
