BY PROVIDING SCHOOL SUPPLIES AT NO COST TO TEACHERS, SCHOOLHOUSE SUPPLIES LEVELS THE EDUCATIONAL PLAYING FIELD FOR ALL STUDENTS. THE FREE STORE FOR TEACHERS SERVES ALL 3,000 TEACHERS AND 46,500 STUDENTS IN THE PORTLAND PUBLIC SCHOOLS SYSTEM, AS WELL AS A BROADER NETWORK OF ORGANIZATIONS ACROSS THE PORTLAND METROPOLITAN AREA THROUGH A VOLUNTEER VOUCHER PROGRAM.
