

In carrying out its charitable purpose, the UBCE Board of Directors has adopted a spending limit of no more than 10% of assets in any given year that can be disbursed for the work of providing education, shelter, food, healthcare, clothing, basic shared amenities, and necessary travel to support the monastic life of the monks and nuns of the UBC and related religious institutions. The UBCE's investment in publicly traded securities are held in a brokerage account. During fiscal year end 6/30/14, the Endowment received donated securities of approximately \$20,000 and they did not have any restrictions on use. As such, they were classified as unrestricted. The remaining securities held in the brokerage account have been classified as permanently restricted in accordance with the donor's intention at the time the contribution was made.

transaction with the UBC Endowment.

The UBC Endowment has taken a number of precautions to ensure that this transaction remains fair and does not violate the

excess benefit transaction rules. First, and most important, all investors in funds held by the Hussman Investment Trust

and managed by Hussman Strategic Advisors, including the UBC Endowment, pay the same fees. The fees paid to Hussman

Strategic Advisors are determined by the open market and on an arms' length basis. A considerable number of persons have

chosen to pay these fees and confirm the fairness of the price. As of June 30, 2014, the two Hussman Funds that the UBC

Endowment held investments in had over 45,000 shareholder and combined assets of approximately \$1.8 billion.

Furthermore, the securities law requires the independent trustees of the Hussman Trust to review the fees and make a

determination each year that the fees paid to the advisor are reasonable. Finally, the legal counsel to the UBC

Endowment has drafted a formal legal opinion stating that the fees are reasonable.

The Unified Buddhist Church, Inc. ("UBC") assigned the rights to certain royalties to the Unified Buddhist Church Endowment for the Training

and Support of Monastics, Inc. ("UBCE"). These royalties were generated by the foreign rights to certain books authored by Thich Nhat Hanh

The UBC owns the intellectual rights and assigned a portion of the rights to the royalties to the Endowment. These royalties were paid by commercial publishers directly to the Endowment.
