During the seventh year of operation, the 2013-2014 school year, Foundation Academy Charter School provided a full range of educational services appropriate for all students in Grades 3, and Grades 5 through 12. The Educational program includes social, health and nutrition services that support the total education of the student. In addition, the educational services include regular, as well as special education instruction. Foundation Academy Charter School promotes the full involvement of parents in their children's educational development. The Charter School completed the 2013-2014 school year with an enrollment of 196 students in its Middle School, while an additional 188 high school students were enrolled in grades 9 thru 12. The Average Daily Enrollment (ADE) for the entire charter school for the 2013-2014 school year was 526 students.
